Honours Scholarship Conditions of Award

1) Introduction

UNSW Canberra offers a number of Scholarships each year, for high achieving undergraduate students who are pursuing an Honours program at UNSW Canberra in the fields of Arts (Humanities and Social Science), Business, Computing and Cyber Security, and Science.

2) Value

The value of the Scholarship will be \$10,000 for each recipient, which will be paid in two equal instalments at the beginning of each consecutive semester for students studying full-time, or four equal instalments, at the beginning of each consecutive semester for students studying part-time.

3) Eligibility

The Scholarship recipient must be an Australian citizen, New Zealand citizen, or Permanent Resident of Australia to be eligible to receive the Scholarship. The recipient must receive an offer of admission to one of the following UNSW Canberra (one year) Honours programs to be eligible to receive the UNSW Canberra Honours Scholarship: Bachelor of Arts (Honours), Bachelor of Business (Honours), Bachelor of Computing and Cyber Security (Honours), Bachelor of Science (Honours). Defence-funded students are not eligible for this scholarship due to Defence sponsorship arrangements already in place.

4) Application

Recipients are not required to submit an application for the UNSW Canberra Honours Scholarship, as all applicants who receive an offer of admission to any of the UNSW Canberra Honours programs listed in Section 3 will automatically be considered for a UNSW Canberra Honours Scholarship.

5) Selection

The Scholarship will be allocated based on academic merit. All applicants who receive an offer of admission to a UNSW Canberra Honours program listed in Section 3 will be ranked based on performance in the bachelor degree that qualified their admission to the UNSW Canberra Honours program.

6) Deferment

The Scholarship must be taken up in the year for which the offer is made and cannot be deferred.

7) Commencement

The Scholarship commencement date will be outlined in the Scholarship offer letter.

8) Enrolment

The recipient must remain enrolled full-time or part-time in the UNSW Canberra Honours program to remain eligible to hold the Scholarship.

9) Termination

The Scholarship will terminate at the end of the final semester of the recipient's Honours program.

10) Repayment of the Scholarship

The recipient may be required to repay some, or all, of the Scholarship funds if the recipient does not complete the UNSW Canberra Honours program.

11) Taxation

The recipient is responsible for seeking taxation advice regarding his/her own individual circumstances.

12) Promotion

The recipient may be requested to participate in activities to promote the Scholarship, which may include the recipient's name being published on the UNSW Canberra website, or the recipient participating in a student profile.
